Reorganization Announcement

Nippon Paint Automotive Coatings Co., Ltd. (“NPAC”), Nippon Paint Surf Chemicals Co., Ltd. (“NPSU”), and Nippon Paint Industrial Coatings Co., Ltd. (“NPIU”) hereby announce that they have resolved to implement a reorganization (the “Reorganization”), effective January 1, 2027.

Under the Reorganization, the businesses of NPSU will be split and integrated into NPAC and NPIU. Through this new structure, the Group will establish a framework that enables surface treatment products and paint products to be delivered in an integrated manner. The Group also aims to further strengthen product development and technical service capabilities, thereby enhancing customer satisfaction.

■ Outline of the Reorganization

The functions of NPSU’s automotive surface treatment business, excluding production functions, will be integrated into NPAC through an absorption-type company split.

All functions of NPSU’s general industrial surface treatment business, including production functions, as well as the production functions of the automotive surface treatment business, will be integrated into NPIU through an absorption-type merger. As a result of the merger, NPSU will be dissolved.

No changes will be made to Manufacturing Equipment and Facilities (Machine), Personnel (Man), Manufacturing Methods (Method), or Raw Materials (Material) as a result of the Reorganization.
